

RESOLUTION NO. 19-xxx

**A RESOLUTION AWARDED THE BID FOR
TWO OUTBOARD MOTORS FOR THE MARINE 1 POLICE BOAT TO
ISLAND BAY MARINE, LLC, IN THE AMOUNT OF \$23,500
AND DECLARING THE TWO EXISTING MOTORS AS SURPLUS AND UNNEEDED**

FINDINGS:

1. Bids for Two Outboard Motors for the Marine 1 Police Boat were received and opened on March 14, 2019.
2. The Police Department has recommended award to the lowest bid meeting specifications from Island Bay Marine, LLC.
3. Low bid includes trading in the existing motors for a credit.
4. Section 11-43-56 of the Code of Alabama of 1975 authorizes the municipal governing body to dispose of unneeded personal property
5. The following personal property owned by the City of Orange Beach, Alabama, is no longer needed for public or municipal purposes:
2016 Suzuki DF300APXX Outboard Boat Motor, Serial No. 30002P-610761, City ID #203-5
2016 Suzuki DF300APXX Outboard Boat Motor, Serial No. 30002P-610004, City ID #203-6
6. City Council finds that the lowest responsible bid was submitted by Island Bay Marine, LLC, in the amount of \$23,500, and that surplus and trading-in the two existing motors is in the best interest of the City of Orange Beach, Alabama.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ORANGE BEACH, ALABAMA, AS FOLLOWS:

1. That the bid for Two Outboard Motors for the Marine 1 Police Boat, as specified by the bid documents, is awarded to Island Bay Marine, LLC, in the amount of \$23,500;
2. That the Mayor is hereby authorized to approve payment to Island Bay Marine, LLC, in the amount of \$23,500 for two (2) 2019 Suzuki DF300APXX2 Outboard Boat Motors, as specified by the bid documents;
3. That the aforementioned two existing boat motors owned by the City of Orange Beach, Alabama, are not needed for public or municipal purposes;
4. That the Mayor and City Clerk are hereby authorized and directed to dispose of the surplus property, as described above, on behalf of the City of Orange Beach, Alabama, by appropriate legal methods; and
5. That this Resolution shall become effective immediately upon its adoption.
